METHOD OF COLLECTING YOUR PERSONAL DATA AND LEGAL REASON

Video recording is made through security cameras located in the entrance doors, building exterior, cafeteria, parking lot, floor corridors and floor service areas in our service building and to ensure building security. Your personal data processed for legal reason per Art. 5/2-f of the Law: "It is mandatory to process data for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject."

YOUR RIGHTS

By applying to Egedeniz Tekstil in accordance with the Article 11 of KVKK, you are entitled to:

- Learning whether personal data is processed or not,
- Learning If personal data has been processed, requesting information about it,
- Learning the purpose of processing personal data and whether it is used in accordance with its purpose,
- Knowing the third parties whose personal data is transferred in the country or abroad,

- e. Requesting the deletion or destruction of Egedeniz Tekstil, without prejudice to its legal obligations, within the framework of the conditions stipulated in Article 7 of the KVKK,
- f. Requesting correction of personal data if it is incomplete or incorrectly processed,
- g. Requesting notification of the transactions made pursuant to subparagraphs (e) and (f) above, to third parties to whom personal data has been transferred,
- h. Objecting to the emergence of a result against you due to the analysis of your personal data exclusively by automated systems,
- i. If you suffer damage due to the unlawful processing of your personal data, you have the right to demand the compensation of the damage.
